Thank you for your email/letter dated 14 December 2021, regarding the above mentioned consultation.

The proposed development has been examined from an aerodrome safeguarding perspective and could conflict with safeguarding criteria unless any planning permission granted is subject to the condition detailed below:

# Submission of a Bird Hazard Management Plan

Development shall not commence until a Bird Hazard Management Plan has been submitted to and approved in writing by the Local Planning Authority. The submitted plan shall include details of:

- Management of the shallow pitched roof on the proposed building which may be attractive to nesting, roosting and "loafing" birds.

The Bird Hazard Management Plan shall be implemented as approved, upon completion of the roof and shall remain in force for the life of the building. No subsequent alterations to the plan are to take place unless first submitted to and approved in writing by the Local Planning Authority.

**Reason:** It is necessary to manage the roof in order to minimise its attractiveness to birds which could endanger the safe movement of aircraft and the operation of Gatwick Airport.

# YOUR LONDON AIRPORT Gatwick

Please find a draft Bird Hazard Management Plan attached, if the applicant is in agreement the methods of dispersal need to be completed where indicated in red and it needs to be signed and dated and submitted to yourselves pursuant to the above mentioned condition.

We will need to object to these proposals unless the above mentioned condition is applied to any planning permission.

We would also make the following observation:

## Cranes

Given the nature of the proposed development it is possible that a crane may be required during its construction. We would, therefore, draw the applicant's attention to the requirement within the British Standard Code of Practice for the safe use of Cranes, for crane operators to consult the aerodrome before erecting a crane in close proximity to an aerodrome. # **Background**

This management plan seeks to minimise the potential birdstrike risk to aircraft operating into and out of Gatwick Airport, which could arise from the development of a new industrial building at Former Royal Observation Corps Bunker, Bletchingley Road, Merstham, approved under planning application number 2021/953.

#### Legislation

The management plan has been developed in response to concerns expressed by Gatwick Airport Ltd concerning the possible birdstrike hazard to aircraft and in the light of EASA (European Aviation Safety Agency) legislation as contained in 'Acceptable Means of Compliance' (AMC) Annexe II and advice as contained in Circular 01/2003 – Safeguarding Aerodromes, Technical Sites & Military Explosives Storage Areas: The Town & Country Planning (Safeguarded Aerodromes & Military Explosives Storages Areas) Direction 2002.

This management plan has been agreed by the developer, Tandridge District Council and Gatwick Airport Ltd as administrators of airport safeguarding matters for Gatwick Airport.

It should be noted that this management plan is designed particularly for the situation at the Former Royal Observation Corps Bunker, Bletchingley Road, Merstham and is not necessarily appropriate for other sites in the vicinity of Gatwick airport.

### **Extent of the Agreement**

The parties identified above have agreed that the management plan set out below shall apply to the Former Royal Observation Corps Bunker, Bletchingley Road, Merstham as detailed in planning application 2021/953. This will reduce the attractiveness of the proposed development to the target species.

This management plan identifies a number of measures which seek to control and reduce the potential birdstrike hazard, through the monitoring of the target bird species and any appropriate action taken.

# **Target Species**

All Gull species.

#### Actions to be Taken:

- The roofs are constructed in such a manner so that all areas are safely accessible to enable any nests and eggs to be cleared and birds to be dispersed.
- Checks will be made weekly or sooner if bird activity dictates, during the breeding season by an appointed person/company. The breeding seasons for gulls typically runs from March to June.
- Any birds found nesting and/or roosting and/or loafing during the breeding season will be dispersed when detected and/or when requested by Gatwick Airport Airfield Operations staff.
- Any nests or eggs found will be removed. A CL12 licence must be obtained from Natural England before any removal takes place, please contact: <a href="mailto:bird.licensing@naturalengland.org.uk">bird.licensing@naturalengland.org.uk</a>

- Checks will be made on a regular basis, as dictated by bird activity, outside of the breeding season by a nominated person/company.
- Any birds found roosting and/or loafing outside of the breeding season will be dispersed when detected and/or when requested by Gatwick Airport Airfield Operations Staff.
- The methods of dispersal used will be as follows: (please list, for example human presence, distress calls etc).
- A log will be kept which will detail the following:
  - Dates and times of inspections
  - Who carried out the inspections
  - Bird numbers and species seen
  - Details of any dispersal action taken along with details of any nests/eggs removed.
  - The log must be available to Gatwick Airport Airfield Operations or their representatives to view upon request.

### **Review of the Management Plan**

The management plan shall be subject to review to reflect changes in habitat or populations of bird species. Should the airport deem it necessary, a meeting between Gatwick Airport Limited, the applicant and/or Tandridge District Council will be convened at the earliest opportunity to discuss and agree any changes which may be necessary.

# **Inspection & Site Access**

Gatwick Airport Limited or their nominated representatives will be allowed access to the site by prior arrangement, to evaluate the success of the Management Plan and to review any remaining birdstrike hazard.

# **Long Term Management**

This Management Plan will remain enforceable by Gatwick Airport Limited, Tandridge District Council, the CAA or any successor to these bodies throughout the existence of the buildings. These obligations will be passed to any subsequent owners/operators of these buildings and land.
